Dear Presidents and members

At an SAEF EXCO meeting held on Saturday the 16th of March 2019, the issue of riders only participating in 1 or 2 shows in a year was discussed. As a token of goodwill, the EXCO approved a day membership fee of R150.00 per day for riders to participate in a maximum of two shows for the year. This fee is applicable to senior and junior riders of all disciplines.

Should a rider after his/her participation in the allowed two shows wish to continue attending more shows then he/she is obliged to join the SAEF as a full member. Should they need assistance, they can contact the SAEF office.

The fee that such a rider has paid for the initial two shows will then be taken into account as a pro-rata fee towards the outstanding balance of the applicable annual SAEF fee, and only the difference then needs to be paid to become a full member of the SAEF.

This arrangement is only for the balance of 2019. As from 1 January 2020 the SAEF will introduce a new tiered fee structure to accommodate various types of memberships.

We urge riders to adhere to the guidelines above as non-compliance can lead to either the rider/discipline or showholding body being given a penalty or fine.

It is the responsibility of the discipline/show holding body to collect these fees when a rider enters a show. The Monday following the show it is the
